Introduction

The Alaska Criminal Justice Data Analysis Commission has created a library of online resources for people seeking information about Alaska's criminal justice system. These data sources are free and public. They include dashboards, reports, the Court System's searchable database, CourtView (and links to the appellate courts' case database), and other resources for research on most topics related to criminal justice in Alaska.

The listing of databases and reports is organized by topic, followed by a list of databases/reports organized by source (e.g., state, federal, national organization, local). It is not intended to be exhaustive.
