I believe my experiences as a Judge Pro Tem and as a contract Administrative Law Judge provide a significant foundation upon which my suitability to be a District Court judge should be considered. As a Judge Pro Tem, I presided over misdemeanor criminal matters including change of plea hearings and sentencing hearings, bench and traffic trials, and hearings for domestic violence restraining orders. The subject matter and types of hearings were very similar to the matters handled by a District Court judge.

As a contract Administrative Law Judge, I conducted hearings involving testimony and evidence from opposing parties to resolve employment disputes. I prepared timely written findings on those matters for the Gila River Tribal Human Resources Department.

As Bar Counsel, I coordinated and participated in a number of hearings for clients seeking financial compensation resulting from the negligence of their disciplined (or deceased) attorneys through the Lawyers' Fund for Client Protection. The hearings involved taking witness testimony, document review, and preparing written findings for the Board of Governors.

Additional Comments (Continued)

Much of the ethics work I do now with the Department of Law is sensitive and confidential. For general background information, I can offer that I conduct investigations involving the Executive Branch Ethics Act into the alleged misconduct of public officers and board and commission members under the executive branch. The investigations include interviews, extensive document and electronic records review, and prepared written findings for the Attorney General and the Personnel Board.

I was a public defender in Alaska approximately 10 years, and I was in court virtually every day. For the years spent in Anchorage my focus was resolving cases involving probation violations and appearing at daily arraignments and bail hearings. I have two trials from my time spent outside of Anchorage. I believe that number is a reflection of my ability to successfully engage in motion work and negotiate with opposing counsel to resolve cases short of trial. It also speaks to the good working relationship I had with opposing counsel and their respect for my advocacy and work product.

During this pandemic I have volunteered to cover District Court hearings for the criminal division. I obtained security clearance and have been covering arraignments, bail hearings, and change of plea hearings when possible.
