I handle cases in all state and federal courts, and have a strong working knowledge of evidence, procedure, and administrative regulations. My criminal experience, albeit now somewhat remote, was extensive from both prosecution and defense. My work for the union members provided extensive criminal defense and family law work, and my stints as a prosecutor exposed me to extensive criminal work. I am still involved with criminal cases handled directly by my partners and associates. Likewise, I am involved in family law matters handled by my office as the cases are staffed and prepared for trial or resolution, although I do not try these cases myself. I have a first-hand appreciation of the financial and emotional cost involved in litigating these matters.

I served a term on the Alaska Commission on Judicial Conduct, including the Ethics Committee, and have a working and practical appreciation of the conduct required of judges in the courtroom. I also served on the Merit Selection Panel for the U.S. District Court Magistrate and have knowledge of the qualities necessary for a successful judge. I have served on the Alaska Commission on Judicial Conduct, and Federal Merit Selection Panel, and the Alaska Bar Association fee arbitration and grievance panels.
