I desire to continue serving Bethel and the entire Yukon-Kuskokwim Delta and I believe my time as a District Court Judge, Superior Court Judge Pro Tem, as well as my time as an assistant public defender provides me with an understanding of the uniqueness of the community I wish to continue serving for the foreseeable future.

I am committed to remaining in Bethel long term as can be seen from the fact that I have not applied for other judicial openings even though others have been available. I applied to the Bethel District Court at my first opportunity and now I am applying to the Bethel Superior Court at my first opportunity.
