Alaska Judicial Council Public Hearing about Judges on the Ballot in November Tuesday, May 12, 2020 4:30 p.m.

On **Tuesday, May 12, 2020 at 4:30 p.m.** the Council will hold a statewide public hearing to solicit comments about these judges (**see list below**).
