The Alaska Judicial Council evaluates judges on a number of criteria, including legal ability, demeanor, diligence, ability to manage their caseloads, and fairness and integrity. Alaska Judicial Council Recommendation Judge Keith B. Levy, District Court, Juneau

Judicial Council Recommendation

The Alaska Judicial Council, a non-partisan citizens commission established by the Alaska constitution, evaluates judges on criteria that include legal ability, demeanor, diligence, ability to manage their caseloads, and fairness and integrity. The Judicial Council finds Judge Levy to be *Qualified* and recommends unanimously that the public vote "Yes" to retain him as a district court judge.

Judicial Council Evaluation

The Judicial Council surveyed 2,884 attorneys and 1,539 peace and probation officers, together with social workers/guardians ad litem, and child advocates, jurors, and court employees about the judges on the ballot. Respondents were asked to rate judicial performance and to submit comments. The Council also reviewed the ratings and observations of the Alaska Judicial Observers, independent community-based volunteers. The Council reviewed court system records concerning peremptory challenges, recusals, and appellate affirmance and reversal rates; any civil or criminal litigation involving the judge; APOC and court system conflict-of-interest statements; any public disciplinary files; and whether a judge's pay was withheld for an untimely decision. The Council investigated judicial conduct in specific cases. The Council interviewed some judges, attorneys, court staff, and others, and held a statewide public hearing to obtain comments about judges.

Summary of Survey Information

Attorneys in Alaska rated Judge Levy on the six categories summarized in the table above, using 5 as the highest rating possible. The attorney rating for Judge Levy on overall performance was 4.4. Peace and probation officers rated Judge Levy on five categories, using the 5-point scale above. They gave Judge Levy a rating of 4.1.

Three other groups also evaluated Judge Levy's performance, using the same 5-point scale with 5 as the highest rating. Jurors rated him 4.8 overall, court employees gave him 4.6, and social workers, guardians ad litem and CASA volunteers rated him at 4.5.

Recommendation: Vote "YES" to retain Judge Keith B. Levy

Since being appointed I have worked hard to learn the many skills needed to meet the demands of the job. I have taken advantage of every training opportunity that has been available. I have also shared the things I have learned by serving on the judicial education committee and planning training conferences for newer judges.

Perhaps the biggest challenge I have faced has been working to organize and then presiding over the Juneau Therapeutic Court. This program is designed to help individuals convicted of felony driving under the influence to get into recovery, avoid long periods of incarceration and further criminal convictions, and become productive members of the community. I believe the program has been a great benefit to the community and to the individuals who have successfully completed the program.


Summary of Findings
