2. Please describe your participation on court/bar committees or other administrative activities during your current term of office.

I am a training judge for three magistrate judges who are located in Seward, Kodiak, and Anchorage.

I am the chairperson of the Criminal Rules Committee.

I serve on the Workplace Conduct Committee, the Fairness and Access Commission, and the Anchorage Security Committee.

I have volunteered to be one of the initial judges to participate in the Online Dispute Resolution program.

3. Please describe any judicial or legal education you have undertaken or provided during your current term in office.

I have attended all of the court system's judicial conferences since becoming a judge. They are held each year, with a modification during the Covid pandemic.

I have presented or co-presented presentations on numerous topics at the court's annual conference or other conferences including the newer judges' conference and the magistrate judges' conference.

Most recently, in 2021 I co-presented at the newer judges' conference on the topic of landlord/tenant law and practice. In 2022 I made a presentation about self-represented litigants at the newer judges' conference. In 2023 I co-presented at the annual judicial conference, focusing on when a defendant can and cannot validly waive the right to an attorney and proceed self-represented, including the extensive inquiry necessary for the court to make such a determination.

4. Please describe any public outreach activities during your current term in office.

I have hosted students on school tours. As part of this, I have developed exercises to engage them in the process. One is a "burden of proof" exercise where I explain what burdens of proof exist in our legal system that must be satisfied to justify different legal actions. I then have students get up and interact with each other to match the burdens and legal actions.

I also developed a witness activity for students to engage in. I place several items around the courtroom and have two participants enter the courtroom, have a conversation, place items into a bag, and leave. Then, one student acts as a witness and the other as an attorney. The attorney attempts to establish facts by questioning the witness about what the participants took, wore, said, etc. This helps make the point that our legal system requires a party to establish facts and develops the skills of questioning and observation.

I have also acted as a judge for the Color of Justice program where I help guide and teach the students who participate as judges, attorneys, and witnesses.

6. Please assess, in one or two paragraphs, your judicial performance during your present term. Appropriate areas of comment could include: satisfaction with your judicial role, specific contributions to the judiciary or the field of law, increases in legal knowledge and judicial skills, or other measures of judicial abilities that you believe to be important.

Anchorage District Court is a high volume court where we repeatedly handle the same types of cases and hearings, including arraignments, bail hearings, changes of plea, sentencing, trials, landlord/tenant hearings, small claims trials, and more. We also handle the vast majority of applications for search warrants and arrest warrants in Anchorage.

While this could lead to burn out, I have found that the essence of my role is not dealing with cases but with people. Each person comes to the court with different life experiences, challenges, and strengths. Each hearing is extremely important to the individual participants and provides an opportunity for them to reflect on the choices they have made, how their actions impacted others, and how to improve their lives. Recent interactions with a person in my life who is experiencing mental health and emotional challenges have further developed my understanding and performance as a judge. I strive to further the accountability of people in court but also to encourage them to overcome their challenges. It is rewarding to be a part of that process.

My first job after law school was clerking for Judge Coats. He made the important observation that while judges and lawyers are accustomed to hearing many cases day after day, individuals with a case might only have one court case in their life. We need to treat each person and case with the seriousness they deserve. I also appreciate my first judicial assistant Dana Hoffman who early in my judicial career told me "judges are public servants also, and if you don't understand that you won't be very good at your job." She was correct. I affixed that quote to the bottom of my computer screen as a reminder. It remains there to this day.

As stated in section 4 above, I have contributed to the judiciary by researching and making presentations to other judges at various conferences.
