

DRAFT Meeting Summary
Alaska Criminal Justice Data Analysis Commission
October 21, 2024
10:00 a.m. – 1:00 p.m.

Chair Matt Claman called the meeting to order at 10:23 a.m. after technical difficulties were resolved by moving the meeting to the Foraker Room in the LIO office. Members present were Lt. Jean Achee (Zoom), Alison Biastock (Heather Phelps), Sen. Matt Claman, Alex Cleghorn (Sam Cherot, Zoom), James Cockrell (Lisa Purinton, Zoom), Tracy Dompeling (Zoom), Terrence Haas (Zoom), Ret. Judge David Mannheimer, John Skidmore (Zoom), Brenda Stanfill, Ret. Judge Trevor Stephens (Zoom), and Rep. Sarah Vance (Zoom, with Jake Almeida). Members absent were Judge Kari McCrea, April Wilkerson, and Capt. Brian Wilson.

Staff present were Susanne DiPietro, Brian Brossmer, Teri Carns, and Susie Dosik.

Adopt Agenda

Ms. Cherot moved to adopt the agenda as presented. Ret. Judge Mannheimer seconded the motion, and members approved it without objection.

Approve September 17, 2024 and October 8, 2024 meeting summaries

Ret. Judge Stephens moved to approve the September 17, 2024 meeting summary. Ms. Cherot seconded the motion, and it was approved without objections. Judge Stephens moved to approve the October 8, 2024 meeting summary. Ms. Stanfill seconded the motion, and it was approved without objections.

Public Comment Period

Chair Claman opened the meeting to public comment at 10:30 a.m. There were no public comments, and the Chair closed the public comment period at 11:11 a.m. He noted that the commission receives public comment at any time on its website.

Final Review of DAC 2023 Annual Report draft

Members reviewed the draft and discussed a variety of changes, including:

Minor typos noted in the executive summary;

Pg 15 -- human trafficking added;

Pg 29 -- Tribal government set-asides for victim programs noted. Ms. Stanfill said that the list of eight types of allowable activities should be added. Ms. Cherot mentioned ANJC funding for work with substance use/abuse addictions;

Pg 30 -- Alaska Institute for Justice added;

Pg 31—Figure 2 approved;

Pg 35 – Language added re “when not a crime of domestic violence.” Also, language re Title 47 added, and other language added in a footnote;

Pg 40 – Paragraph re booking procedure from DOC policies and procedures added, and citation in footnote;

Pg 44 – The new language re indictments was modified slightly;

Pg 46 – Language re the DOL sex offense summary was approved;

Pg 50 – Language re types of pretrial risk assessments was approved;

Pg 52 – Language in 5.5 was revised slightly;

Pg 52-53 – Language in 5.5.1 re VCOR revised slightly;

Pg 53-54 – Language in 5.5.2 revised to remove information about earlier bail study, and other changes; Ms. DiPietro noted that the report emphasized the use of “people-forward” language throughout;

Pg 55—Minor editorial changes to 5.8 Grand Jury;

Pg 64—“Imposed” substituted for “sentenced,” and the definition of “imposed” will be added to the Glossary of Terms;

Page 65 – Minor editorial changes to first paragraph, and to revised Table 5;

Ppg 66-68—Minor changes to restitution discussion;

Ppg 85-87 -- DBH and DOC report on recidivism reduction fund spending approved with minor editorial changes;

Pg 94 -- New Figure 29 approved;

Pg 104 – Definition of “imposed” [sentence] will be added;

Ppg 124-125 – Reports (required by statute) from DBH and CDVSA will be added.

Chair Claman called for a motion to approve the final 2023 DAC Annual Report. ___ moved to approve the report as modified. Ret. Judge Mannheimer seconded the motion and members approved it without objections.

Update on DV Report

Ms. DiPietro said that staff continues to work on the new analyses.
